To calculate FTEs for seasonal workers, I would use the following example:

- Two three month workers (.25 of year) work 15 hours a week, so
- $15 + 15 = 30$ hrs/wk
- $30/40 = .75$ FTEs
- $.75 * .25 = .1875$ FTE for entire year (based on working only three months)

Washington branch library come to an end and, with it, a chance to change some operations for the better. Bullitt County Public Library started offering a new Lucky Day collection with popular fiction titles and videos to more quickly meet patron demand for new releases, which we coupled with a restructuring on how many copies of items the library needed overall to meet the needs of a growing county. Also, work began on incorporating the methods and practices of collectionHQ on both weeding and collection development, as it was determined that the selection of titles on the shelves was not of interest to the patrons and use was too low to justify keeping every book based solely on reviews and awards. At the very end of the year, a large project was started to add new holdings codes and collections in order to better divide books into more popular and browsable sections.
