Randy is still working on the drainage ditch in front of Dorothea Stottman Library. Randy and David Strange have talked to the Hillview mayor. He is in the process of getting a bid for the cost of correcting this ditch.

We are still working on the Lebanon Junction land acquisition. Randy has contacted Patrick Flynn, but Mr. Flynn is trying to contact CSX. It will probably be the middle of December before Randy will hear back from him.

We have hired one new person with two more to start in a few weeks. These people will be scheduled out in the branches to cover spots were there are only two people at a time.

David Strange wanted to announce that on December 20th, there will be a 90th anniversary of the famous train wreck that occurred in front of the Ridgway Library. The ceremony will begin at 5:00 in the county court house on the second floor.
